

### **Project Assistant or Junior Associate – development of new international projects in the area of security**

#### **DESCRIPTION**

SAFE is currently looking for a Project Assistant or Junior Associate with project drafting and commercial/business development skills to support the design and set-up of new international projects in the field of security, as well as assist in their implementation.

#### **TASKS:**

- Business Development - Scouting of funding opportunities in the security sector;
- Drafting of new project proposals;

- Identification of new partnerships with public and private actors in the EU and development of existing institutional network;
- Drafting of policy papers and technical reports;
- Monitoring of projects' activities and targeted support to daily project implementation and management (e.g. invoices, documentary proofs, project book-keeping, etc.);
- Support in the organization of logistics for events, seminars and other project activities, including online meetings and workshops;
- Drafting of news and meeting minutes.

**REQUIRED EXPERIENCE:**

- Previous working experience in the security, defence, human rights, and/or development sectors, with a focus on business development and drafting of project proposals;
- Bachelor's and/or Master's degree in Economics, International Relations, Law, Criminology, Intelligence, National Security, International Development or related fields and sub-fields;
- Post-graduate thesis on topics related to any of our activities and focus areas is an advantage;
- Certification or proven experience in project management is desirable;
- Proven knowledge of EU and neighboring countries/regions security context is an advantage;
- English proficiency required;
- Good knowledge of French, Spanish and/or Arabic is an advantage;
- Ability to work under pressure and to respect deadlines. Highly motivated and dynamic. Candidates must also possess critical thinking and organisational skills.
