- Excellent project proposal writing skills and knowledge of EU programmes in terms of project proposal presentation requirements.
- Excellent project management, coordination and organisational skills.
- Excellent networking and business development skills.
- Attention to detail and proactivity are essential skills.
- Ability to work under pressure and to respect multiple deadlines. Highly motivated and dynamic with strong chain analytics.
- English proficiency required; working knowledge of other languages, in particular French and Arabic, is an asset.
- Proven knowledge of EU and neighbouring countries/regions security and defense context is an asset.
- Knowledge of the thematic field of environmental crimes is considered an asset.
- Availability to travel is an asset.
- Post-graduate thesis on topics related to any of our activities and focus areas is an advantage or direct work experience as Law Enforcement Agent, Military Officer, First Responder or similar are considered distinct advantages.
- Experience on training and testing activities in the security and defence sector is considered a distinct advantage.
